

PONY PARTY PLACE

Permission Slip and Liability Waiver

Permission slips and waivers are required for all activities, parties, trail rides, lessons, camps, and traveling pony.

WARNING

Under Minnesota Statute 604A.12 of the Sponsor(s) of livestock activities are not liable for the injury or death of a participant, or a spectator in an unauthorized area, arising from the inherent risk of livestock activities. Inherent risk means the dangers arising from the propensity of livestock to behave in unpredictable ways, including kicking, biting, spooking in response to sound, sudden movement, unfamiliar objects, persons and other animals. The undersigned agrees for himself or herself, dependents, heirs, executors, administrators, assigns and for persons coming onto the premises with the undersigned's express or implied permission, invitation or knowledge to assume all risk and hazards and agree to fully INDEMNIFY, DEFEND AND HOLD HARMLESS, Pony Party Place and their owners, interns, volunteers, and representatives (hereinafter "Stable"), from: (1) any and all claims, demands, liability injuries, death, property damage or loss or other remedies or damages arising out of or resulting from the INHERENT RISKS of participating in or observing horse related activities including but not limited to, the risk of horses kicking, biting, spooking, tripping and falling, and from (2) any and all claims resulting from the NEGLIGENCE, vicarious or direct, of the stable including but not limited to horse and pony rides, trail rides, riding lessons, parties, clinics and exhibitions, leased horses, scout badges, camps, failure to check or maintain equipment, the operation, maintenance and supervision of the premises, improvements to real property or the boarding, training, breeding, or keeping of horses on the premises.

In order to ride, the rider must be five-years-old or older.

For the safety of the animals piñatas and balloons are not allowed.

Parents must supervise children at all times.

Pony Party Place is not responsible for accidents. Pony Party Place is not responsible for unsupervised children on the property.

Riders under the age of 18 are **REQUIRED TO WEAR A HELMET**. Bring your own or wear one of ours. Anyone not wearing a helmet may not ride.

You agree to not hold Pony Party Place responsible if any participant contracts Covid-19.
